2. Setup is on Saturday (7/16) between 10am-6pm only.
3. Registered vehicle participants can enter early on Sunday (7/17) between 8am-11am.
4. Move out (breakdown) is on Sunday (7/17) after show has ended at 6pm only.
5. All cars displayed must have ¼ tank of gas and must disconnect battery prior to displaying vehicle.
6. There will be additional charge for the following: overnight trailer parking and electricity for your space (specify on application form).
7. Parking will be free for registered participants on Sunday (7/17) if you are there by 10am. After 10am the venue will be charging for public parking.
8. In and out privileges are not allowed for day of show, 7/17.
9. Extra wristbands for entry must be purchased and paid for in advanced. No wristbands will be sold during set up or day of event (7/16-17).
10. We have the right to terminate your registration for any reason at any time.
